Performance Guidelines

1. We reserve the right to change or eliminate acts due to inappropriate language, clothing, contents, or student behavior. Words, movements in dances, and costumes must be Christ honoring as determined by the auditioning committee. As stated on pg. 36 in the parent handbook: "It is expected that students (of FWC) will conduct themselves in ways which will honor Christ."
2. Each student will be allowed to participate in ONE SOLO ACT and/or ONE GROUP ACT ONLY (max of 2 entries) and must be a student of Fort Worth Christian School.
3. Each child will be allowed 4 minutes for his/her performance.
4. **Friday, February 17, 2012** Parent consent forms AND a copy of all lyrics involved with the act must be submitted. All students must turn in a consent form in order to participate in the auditions and final performance.
5. The consent form needs to be filled out completely. Please note if you have more than one person in your act each student needs to turn in a signed consent form.
6. Each act must audition on **Friday, March 2, 2012** after school, times and order to be announced later. The act does not have to be perfect at this time but polished enough for the auditioning committee to determine if it fits the criteria.
7. Any music used must be on CD and please have Song # , child's name, grade and teacher marked on back.
8. Each act must provide its own costumes, props, music, accompaniment, etc. for the Audition and Final Performance.
9. For any music used, singing or dancing, make sure it is "rated" for general audience and you must provide a written copy of song lyrics with your consent form.
10. Music CD's used for vocalists must be "karaoke style." No voices, only the accompaniment.
11. Students need to come up with a NAME FOR YOUR ACT.
12. Students are expected to rehearse at home. We will have mandatory dress rehearsal prior to the show on **Thursday April 19, 2012**. Please take note that this year the talent show is in the evening. **Friday, April 20, 2012 at 7:00pm in the Campus Center**.
13. We will not be able to honor any special requests to have your child perform at a specific time.
14. We would like all students who are participating in the talent show to stay through the evening's final performance. This is out of courtesy to their peers.

Auditions for MC: The MC is the Master of Ceremonies. They announce each act and allow time for set up of the next act. You must arrive with a couple of jokes or ideas for how you would entertain between acts. We will be collaborating with the selected MC to write a script for the show.

Stage hands: Stage hands will be helping with lights, sound, curtain and any movement of sets needed for the acts. You need to have a parent consent form signed to be allowed to be a stage hand.

All students must have an individual written consent form in order to participate.
